Only the product warranty of either the Panorama® PremierPlus Residential warranty or Solar Gard® Armorcoat® PremierPlus Residential warranty is transferable. The owner at the time the window film is installed has coverage for lifetime of ownership. The next owner and only the next owner has 5 years of product coverage. To be eligible to transfer the Warranty:

- The Warranty must be for residential use;
- You must be the first subsequent owner of the residence containing the Product covered by the Warranty,
- The Warranty must still be in effect; and
- You must follow the transfer process set forth in the "How to Transfer the Warranty" section below.

If the above is true, the Warranty may be transferred to you by following the transfer process set forth below.

THE WARRANTY MAY NOT BE TRANSFERRED IF IT WAS FOR A COMMERCIAL USE.

**How to Transfer the Warranty:** To transfer the Warranty from the original owner to you, you must qualify for the transfer of the Warranty under the requirements set forth above.
